## MINUTES OF THE ROCKVILLE BOARD OF APPEALS MEETING NO. 01-2016 Saturday, January 9, 2016

## I. PUBLIC HEARING

**A. Variance Application VAR2016-00056**, Brian Shahkarami, 544 West Montgomery Avenue - for a maximum variance of 14'-6" from the minimum front yard setback requirement of 25 feet to construct a covered enclosed porch; and a 5'-7" variance from the minimum front yard setback for the original placement of the house on the west side. The property is zoned R-60 (Single Unit Detached Dwelling, Residential Zone).

Nicole Walters presented the staff report and recommendation, which is for approval.

Dr. Mork asked about the side setbacks as they apply to this corner lot.

Mr. Shahkarami explained the reasons for requesting the variance. In response to a question from Mr. Curtis, he stated that he would trim the trees that currently screen the porch.

Dr. Mork moved, seconded by Dr. Wilcox, to approve Variance Application VAR2016-00056, based on the findings stated in the staff report and the conditions stated in the staff report, with an additional condition to maintain screening between Aberdeen Road and the enclosed porch. The motion passed by a vote of 3-0.
