Weekly and Monthly Public Safety Information

The Rockville City Police Department would like to provide a few winter storm tips:

Have emergency supplies on hand:

- Battery powered radios, flashlights, lamps, candles (battery powered) and extra batteries. (NOTE: Regular candles are not recommended due to them being a fire hazard.)
- Crank style flashlights and radios.
- Food: Make sure to have non-perishable food items such as canned goods
- Water, can opener (manual), canned food, non-perishable and foods not required to be cooked, and energy bars.

Be prepared in case you end up isolated in your home:

- Make sure you have sufficient heating fuel.
- If you are using a wood burning fireplace or stove, make sure you have plenty of seasoned wood and to open the flue when burning wood.
- Always keep fire extinguishers on hand. • NEVER USE GRILLS OR GENERATORS INDOORS!

During a winter storm:

- Listen to the radio/television for reports and emergency information.
- Dress in layers, loose fitting, lightweight warm clothing.
- Mittens are warmer than gloves. Wear a hat!
- Cover your mouth with a scarf.
- BE CAREFUL SHOVELING SNOW! OVER EXERTION CAN BRING ON A HEART ATTACK.
- Watch for signs of frostbite and hypothermia.
- Check on the elderly or folks living alone.
- Monitor children playing outside.
- Limit pet(s) exposure to the elements.

Rockville City Police Reported Incidents

The Rockville City Police Department provides a weekly Crime Report of serious incidents to serve as an overview of police activity occurring within the City Limits of Rockville. Please note this summary does not include every reported incident that has occurred during this time frame.

It is to be noted that the words “arrested” and “charged” do not imply guilt.

ARRESTS
