DON'T FALL FOR PHONE OR EMAIL SCAMS

Scammers can falsify caller ID to impersonate police, other government agencies, or your utility company. If you receive a phone call, email, or text message instructing you to:

Purchase a **gift card** or **prepaid debit card**,

Buy **cryptocurrency**, a **wire transfer**, or **money order**,

To **pay unpaid taxes**,

To **pay a utility bill**,

To **pay for emergency medical treatment**,

To **avoid arrest...**

It's a scam! No real government agency will ever call you and demand payment to avoid arrest or investigation, and there's never a good reason to pay any organization with a gift card or prepaid card.
