POLICE CRIME REPORT

BE ABLE TO RECOGNIZE HUMAN TRAFFICKING

January is **National Human Trafficking Prevention Month**, a time to rekindle our efforts against forced labor and the commercial sex trade of millions of men, women, and children. You can help simply by learning some possible signs of human trafficking:

Human trafficking victims can be anywhere, but particularly at **restaurants**, **elder care centers**, **salons** and **spas**, **agricultural fields**, **hotels**, and **construction sites**.

You may learn that victims are living with their employer, living with multiple others in cramped or poor conditions, or may have their employer holding their identity documents. You may not be allowed to speak to a potential victim alone, or their answers appear scripted or rehearsed.

1600 block of East Jefferson Street, the complainant reports that an unknown subject removed home-goods from a business without paying for the items at 2:55 p.m. on 01/15/22. **Incident received: 11/23/22. The subject is described as:**

B/M – approx. 6 foot, 6 inches tall, bald, clean shaven – Last seen wearing: gray cap, black mask, black shirt and pants, and a pink backpack

2000 block of Veirs Mill Road, the complainant reports being approached by an unknown subject making bizarre statements and then damaged the complainant's vehicle window at 12:08 p.m. on 01/19/22. **The subject is described as:**

H/M – Last seen wearing a black jacket, black pants, a black hat, and driving a gray Toyota with Maryland plates

1900 block of Veirs Mill Road, the complainant reports being approached by two subjects who attempted to rob him at knifepoint. When the complainant fled, the two subjects reportedly stole cash and damaged his vehicle. **The subjects are described as:**

B/M – approx. 6 foot tall, 180 pounds, medium-build, 23-27 years old, clean-shaven, short hair – Last seen wearing a black shirt and black pants

B/M – approx. 5 foot, 8 inches tall, thin-build, clean-shaven, medium complexion – Last seen wearing a gray or green jacket

1800 block of Rockville Pike, the complainant reports that an unknown subject assaulted an employee during a dispute over store policy. **The subject is described as:**

B/F – medium-build – Last seen wearing: a yellow-knit cap, dark-green jacket, pink scarf, blue pants, and black shoes
