POLICE CRIME REPORT

YOUR SUMMER HOME IMPROVEMENT PROJECT CAN PREVENT CRIME, PART 1

The National Institute of Justice shows that Crime Prevention Through Environmental Design (CPTED) [is effective](#) at reducing crime.

CPTED uses landscaping, architecture, and home-design to reduce opportunities to perform and conceal crime and evoke a sense of neighborly cohesion and care.

For the next few weeks, we'll highlight a principle of CPTED to inspire you to make your summer home-improvement project also a crime-reduction project.

Principle 1: Demonstrate ownership and proper use

Imagine a community garden where crops are grown freely and neighbors don't distinguish between who grows what. How might a neighbor prevent a passerby from stealing their crops?

Imagine a rowdy row of bars in a mixed commercial-residential slice of town. How do bar patrons know that an adjacent neighborhood of rowhomes is to be left alone?

In both situations, the neighbors must clarify who owns what and what their spaces are for. That way, offenders will be less comfortable creating disorder because it's obvious they're breaking a respected rule and that it'll be difficult to claim a misunderstanding.

The community gardeners, then, can add small signs with their first name to their garden tracts and the rowhouse neighbors might develop a consistent color scheme to their home facades that distinguishes their community from retail.
